Booster Club Regulations

Booster Clubs are an extension of the member team and are therefore not permitted to pay players any additional compensation without ECHL League Office approval.

The Booster Club may present gifts or de minimis rewards to players for certain honors if pre-approved by the ECHL office. For example, the Booster Club may pay the Player of the Month a \$50 gift certificate to a local restaurant.

If the member team provides the items used by the Booster Club to generate revenue, this revenue cannot be distributed back to the team's players in any form without ECHL League Office approval.

Member teams cannot make cash donations or other gifts in kind to the Booster Club that are subsequently distributed to the players.

Prior to the start of each season, each Booster Club must submit a detailed list of all planned cash or cash equivalent gifts to be given to ECHL players during the upcoming season.

Items and issues not covered in the ECHL Booster Club Regulations must be submitted to the ECHL League Office for approval.



ECHL Booster Club Provisions

As outlined the following items are permitted to be provided by ECHL Booster Clubs and/or their members to ECHL players and/or member teams:

- Apartment furnishings: Linens, pillows, dishes, cookware, etc (i.e. basic needs items)
- Juices, snacks, videos for extended road trips
- \$50 award (maximum amount allowed per award) for Offensive and/or Defensive Player of the Month Awards (must be in the form of a gift certificate/card, not redeemable for cash)
- \$25 gift certificate only for hat trick or shutout
- Welcome cookout/dinner/gathering, holiday dinner, end of season awards banquet/dinner
- Scrapbook at the end of the year with press clippings

The following items are NOT permitted to be provided by ECHL Booster Clubs and/or their members to ECHL players:

- Portion of anything sold with player's likeness (i.e. picture buttons, cards, sticks)
- Payment for player appearances at special events (i.e. auctions, meetings, sponsor events, etc.)

The following items require league approval prior to being given by ECHL Booster Clubs and/or their members to ECHL players:

- Christmas and/or Birthday Gifts
- Any monies to be paid to the players (except as provided in this memo)

Approval for all items may be obtained by submitting the enclosed ECHLBC Approval Request Form.
